- Accessorial increases detailed above apply to all shipments within and between the U.S., Canada, and Puerto Rico for all air freight services.
- All charges are stated in USD unless otherwise specified, and are applied per occurrence.
- Accessorial charges and fees are subject to change without prior notice.

- The impact of these changes to your shipping costs will vary according to your shipping characteristics and the terms of your agreement with UPS.
