UPS Express Critical® Air Fuel Surcharge

UPS Express Critical uses an index-based air fuel surcharge that is adjusted monthly. The surcharge is based on the *U.S. Gulf Coast prices for kerosene-type jet fuel* as reported by the U.S. Department of Energy for the month that is two months prior to the adjustment. Changes to the air fuel surcharge are effective the first Monday of each month and posted two weeks prior to the effective date. Effective April 5, 2010, the surcharge is 19.00%, based on the February *U.S. Gulf Coast Jet Fuel Price* of \$1.9894 per gallon.
