Less-Than-Truckload (LTL) Fuel Surcharge

UPS Supply Chain Solutions fuel surcharges are indexed to the *On-Highway Diesel Fuel Prices*, as reported by the U.S. Department of Energy and published on its website each Monday*. Fuel surcharge rates are updated weekly and are applied to shipments originating Tuesday through the following Monday. The LTL fuel surcharge for the week of February 2 – February 8 is 21.00%, based on the published diesel fuel price of \$2.781 per gallon on February 1, 2010.
